Sub: Consolidated Scrutinizer's Report for passing of resolutions through remote e-voting and e-voting conducted during the 27<sup>th</sup> Annual General Meeting (AGM) of the members of TRESCON LIMITED ("the Company") held on Wednesday, 28<sup>th</sup> September, 2022 at 3:00 PM (IST) by means of Video Conferencing ("VC") / Other Audio Visual Means ("OAVM").

I, Raghunath Bhandari, Proprietor of M/s. R. Bhandari & Co., Company Secretaries (COP No. 15381), having office at Office No. 9, Behind 'B' Wing, Pushp Vinod No. 1, S. V. Road, Borivali (West), Mumbai – 400 092 was appointed as a Scrutinizer by the Board of Directors of the Company at its meeting held on 12th August, 2022 to conduct and scrutinise the remote e-voting and e-voting process during 27<sup>th</sup> AGM held on Wednesday, 28<sup>th</sup> September, 2022 by means of Video Conferencing ("VC") / Other Audio Visual Means ("OAVM") under the provisions of Section 108 of the Companies Act, 2013 ('the Act') read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR") and Secretarial Standards on General Meetings (SS-2) issued by the Institute of Company Secretaries of India, in a fair and transparent manner, for passing of the Resolutions as mentioned under item numbers 01 to 03 as set out in the Notice of the 27th Annual General Meeting (AGM) of the members of the Company, held on Wednesday, 28<sup>th</sup> September, 2022 at 3:00 PM (IST) by means of Video Conferencing ("VC") / Other Audio Visual Means ("OAVM") as per the General Circular No. 14/2020 dated 8<sup>th</sup> April, 2020, 17/2020, dated 13<sup>th</sup> April, 2020, 20/2020, dated 5<sup>th</sup> May, 2020, 02/2021, dated 13<sup>th</sup> January, 2021, 02/2022, dated 05<sup>th</sup> May, 2022 and all other applicable laws and circulars issued by the Ministry of Corporate Affairs (MCA) and Circular no.



SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated 12<sup>th</sup> May, 2020, SEBI/HO/CFD/CMD2/CIR/P/2021/11 dated 15<sup>th</sup> January, 2021 and SEBI/HO/CFD/CMD2/CIR/P/2022/62 dated 13<sup>th</sup> May, 2022 issued by Securities and Exchange Board of India (SEBI) (SEBI Circular).

- 1. The management of the Company is responsible to ensure the compliances with the requirements of the Companies Act, 2013 and Rules made thereunder and the applicable provisions of the SEBI LODR and MCA and SEBI circulars relating to voting on the resolutions through electronic means (by remote e-voting and by e-voting system at AGM) as stated in the Notice of AGM of the members of the Company. My responsibility as a Scrutinizer for the voting process through electronic means (by remote e-voting and e-voting system at AGM) is restricted to make a Consolidated Scrutinizer's Report of the votes cast "in favour" or "against" the resolutions, based on the reports generated from the e-voting system provided by Central Depository Services Limited ("CDSL"), the agency engaged by the Company to provide remote e-voting and e-voting facility during the AGM.
- 2. As per the confirmation received from the Company, the Notice dated 12<sup>th</sup> August, 2022, of the 27<sup>th</sup> AGM along with explanatory statements setting out material facts pursuant to Section 102 of the Companies Act, 2013 was sent as on 03<sup>rd</sup> September, 2022 by email to members who had registered their Email-ID's with Company/Depository Participant(s) and furnished the same with M/s. Satellite Corporate Services Private Limited, the Registrar and Share Transfer Agent (RTA) of the Company and the same was hosted on the website of the Company and RTA's.
- 3. As prescribed in the Clause (v) of sub rule 4 of the Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company has published advertisement about providing E-voting facility in Newspaper named "Financial Express" (English Newspaper) and "Mumbai Lakshadeep" (Marathi Newspaper) on Sunday, 4<sup>th</sup> September, 2022. The notice published in the newspapers carried the required information as prescribed in Sub Rule 4(v) (a) to (h) of the said Rule 20.
- 4. The voting rights were reckoned as on 21<sup>st</sup> September, 2022, being the Cut-off date for the purpose of deciding the entitlement of Members for remote e-voting and e-voting at the AGM.
- In terms of the aforesaid Notice, remote E-voting was kept open for 3 (Three) days from Sunday, 25<sup>th</sup> September, 2022 (09:00 a.m. IST) till Tuesday, 27<sup>th</sup> September, 2022 (05:00 p.m. IST) as prescribed in the Clause (vi) of the sub-rule 4



of the Rule 20 of the Companies (Management and Administration) Rules, 2014. Members were required to cast their votes electronically conveying their assent or dissent in respect of the Ordinary Resolutions on the e-voting platform provided by CDSL.

6. Pursuant to Rule 20(4)(vii) of the Companies (Management and Administration) Amendment Rules, 2015, for the purpose of ensuring that Members who have cast their votes through remote e-voting do not vote again at the AGM, after closure of period of remote e-voting. I referred the list providing details relating to Members who have cast their votes through remote e-voting, such as their names, folios, number of shares held by them.

During the 27<sup>th</sup> Annual General Meeting held on 28<sup>th</sup> September, 2022, Company conducted e-voting for those Members, who could not participate in the remote e-voting to record their votes.

- 7. After voting at the AGM concluded, I unblocked the results of the remote e-voting and e-voting by Members at the AGM on the e-voting platform of CDSL in the capacity of Scrutinizer in the presence of two witnesses, Mr. Akshay Sayta and Mrs. Bhavna Joshi who are not in employment of the Company and downloaded the results.
- 8. Consolidated e-voting results with respect to each item on the Agenda as set out in the Notice of 27<sup>th</sup> AGM dated 12<sup>th</sup> August, 2022 are enclosed.

It is observed that 61 Members casted their votes through remote e-voting and 3 Member casted his/her votes through e-voting at the AGM.
